Simple Secrets to a Happy Life

Embassy Suites in North Canton, OH.



#### Code of Ethics

It has been my privilege to have the opportunity to talk with newly hired RCA's during the first day of their orientation at the Citygate mail processing center in Columbus.

Because I believe that Rural Carriers are some of the most honest, ethical committed, loyal, dependable people

that work for the United States Postal Service, I like to hit the section on the Code of Ethics pretty hard. I extoll these new employees to not let me down as Ohio tends to have the cream of the crop!

For many of us it may have been quite some time, if ever, that we have reviewed the "Code of Ethics for Government Service". Now might be a good time.

My words from the ethics section that I hope leave an immediate and lasting impression on these inexperienced trainees are "if it's not yours, don't take it!" Taking something that is not yours can have an immediate and lasting effect on your career, like the end of it! It makes me think of something that Delbert Hutchisson, past District Representative, used to say. "What coupon is worth a million dollar career and possibly a million-dollar retirement?"

But sometimes even being the best you can be can have a cost. Because we take pride in our employment, we want our employer to succeed, we want the customer to receive the services they are entitled to, because of our loyalty we reach beyond the expectations of our negotiated contract. It may be because of a sudden change in circumstances, or because management has failed to live up to there responsibilities, but whatever the case may be many of us will jump in and whether it be voluntary or a paid situation, we jump in and help out. It can be anything from route sorting raw mail, or throwing parcels, or covering multiple routes. We help to solve the problem. Where we get into trouble is that once a problem is solved, it is no longer a problem. The generous volunteerism stops being appreciated and becomes expected. Soon the expected becomes a duty.

I am not against anybody making an extra buck! And believe me, if you have been forced to do work that our craft is not entitled to, you need to be paid for it. But invariably, the extra time and the extra work grows beyond the worth of what you may be being paid to do it.

I have been a great proponent of the evaluated system. I have always preferred to be compensated for doing a defined job rather than being paid for my time. Our job is defined by the PO-603:

Rural Carrier Duties and Responsibilities.

This is a section of the orientation that I probably emphasize the most. If we are being paid for the job, we need to know exactly what the job is, what is expected of you and what you are entitled to.

For many of us it may have been quite some time, if ever, that we have reviewed the PO-603: Carrier Duties and Responsibilities! Now might be a good time!

#### MEMBERSHIP

As of February 1, 2023, the Membership Analysis prepared by the National Office has Ohio's total membership as 4246. Ohio has experienced a decrease of 101 members within the past year. The decrease is contributed to RCAs

leaving the craft to become City Carriers and newly hired RCAs not becoming members. Currently Ohio has 811 non-members this is a decrease of 22 non-members compared to this time last year. Thank You everyone who has recruited a non-member. If you know of a non-member recruit them to become a member of the NRLCA. There is an incentive offered by the NRLCA to recruit a non-member.

#### **RETIRING SOON**

If you are retiring soon there is no need to alert the State Secretary. The USPS will notify the union. The State Secretary will send you a letter explaining what you need to do to remain a member of the NRLCA. Your current NRLCA Membership continues for 90 days after your retirement date. You will need your CSA number that (OPM) Office of Personnel Management assign to you to complete an 1187R authorization for dues to be withdrawn from your retirement check. The State Secretary will send all recent retirees a membership form to remain a member.

#### **OWCP OR LWOP NEGATIVE EFFECTS!**

If you are not receiving a check from the USPS your life insurance may lapse because of nonpayment, contact Human Resources on this issue. Also, if you are on Worker's Compensation your dues payments are not deducted from your check. If your dues have not been paid you are not a member in good standing. A "member in good standing" is a member who has made payment of dues and has not voluntarily withdrawn or been expelled or suspended by the Association. Only members in good standing may have Rural Carrier Insurance Programs or be nominated and elected as a delegate to the State or National convention. If you are on OWCP or LWOP make sure that your union membership remains current contact NRLCA Membership at 703-684-5545.

PRINTARING FOR RESTURBING

What is too soon to prepare for retirement?

It is never too soon. Recently I contacted Joni Montroy with Key Retirement Solutions to guide me in the correct direction and time to retire.

Joni is a former employee of the USPS from the Human Resource Department and has ventured on her own to help all government employees in their retirement planning. The small amount of money charged by a retirement specialist can only benefit you in retirement.

Remember, retirement counseling not through the USPS may take several months to schedule so please plan for this timeline.

Knowing the correct percentage amount to deposit in to your Thrift Savings account early in your postal career to prepare for your retirement is essential. You must elect five percent out of your weekly check to have the USPS to match this percentage. The postal service is automatically taking out five percent to all new career employees. If you are a rural carrier that has not put in the five percent to have the USPS match this percentage, please do this to best benefit yourself with this free money. You can do this easily by going to the lite blue page and then to the TSP website. I have made it a policy that whenever we get a raise that I offset this by depositing this percentage wage increase in to my TSP.

When depositing money from your check in to TSP, you have the choice of Traditional TSP (pre-tax) contributions are taken out of your paycheck before your income is taxed. This lowers your current taxable income and gives you a tax break today. You also have the choice of Roth TSP (after-tax) contributions are taken out of your paycheck after your income is taxed. When you withdraw funds from your Roth balance, you will receive your Roth contributions tax free. You have the choice of splitting your deposited money with percentages going as you choose in to each of the above accounts.

The deposits or investments into TSP can also be put into any of the money earning accounts available through TSP. I suggest you go on the TSP site and study the investment accounts which best suit your life style today and in to retirement. Also, there are loans available on your TSP account that is at a very, very low interest rate. When you get a loan from TSP, the money borrowed is out of your own TSP account so when you make a weekly payment (automatically taken out of your check) this amount goes back in to your TSP account along with the interest.

The Fall Booster is set to be scheduled for the first weekend in November in the Columbus area. Joni Montroy from Key Retirement Solutions will be our speaker. This seminar will be held on a Sunday so that all rural carriers will be able to attend. What you learn from the seminar will help you better yourself in the knowledge needed to retire whenever you choose to retire.

Remember knowledge gives you the wisdom to make smart decisions.

Most importantly, there is no better place than the district meetings to stay on top of the latest updates on the RRECs system and our contractual rights. Bring all your thoughts, concerns, and questions to your meetings. Our stewards will be there to continue the education to build our knowledge of the RRECs system. This is where we all learn from each other. However, you choose to access career information and education, PLEASE use these resources! They are the benefits of being a union member.

#### Change

Change in this union occurs when you put down your phone and attend a meeting this spring, when you write a resolution or amendment and attend the state convention to fight for its merits on the floor. Change in this union will only happen when you care as much about showing up and fighting for yourself as you do about talking the union down and feeling helpless.

How many times have you thought that it would be a good idea if you were represented by people on the national board who have actually carried mail this decade? Or even last decade for that matter? How many times have you thought there should be term limits for officers so that the same group of people who represented you before FSS existed aren't still representing you after FSS has been eliminated more than a decade later?

There is a page in this very magazine that will allow you to write an amendment to change both the state and national constitution. You only must take the time to care enough to write it out and mail it to the state secretary before the deadline.

Last year saw a very low turnout at the state convention with only 85 delegates showing up to represent over 4300 carriers.

That left more than 550 empty chairs where there could have been a voice talking and a person voting for the change this union so desperately needs! If you want things to start to change, if you want this union to evolve and progress then you must start showing up and making your voices heard!

At every upcoming spring district meeting there will be an opportunity to sign up to be a delegate for this year's state convention. The OHRLCA pays you \$100 per day that you attend the convention as a delegate! The OHRLCA gives you a free lunch every day! Your vote counts the same as a first-time attendee as any other delegate, even one who has been there twenty times before. How many more years are you going to sit it out and let others decide what you do everyday at work? How many more years are you going to stand by silently while others make decisions you don't approve of?

The state convention is June 11 to June 13, 2023, in North Canton, Ohio. If you really want to make change happen, you need to care enough to be there. #### **Did You Know?**

Our union has a death benefit program available to all members and their spouses.

The PROVIDENT GUILD is a non-profit, fraternal organization that was created and operated by rural carriers.

The following is a brief history of The Provident Guild as presented

by then Provident Guild President Cameron Gray. \*On July 22. 1931, seven rural carriers met in conjunction with a state carriers' meeting at Mt. Vernon. Ohio. They agreed to sponsor a Fraternity to be known as The Rural Carriers' Provident Guild. Its purpose was to develop a spirit of brotherly love among its members and to provide financial relief to the beneficiaries or dependents of deceased members of the Guild. Officers were elected and the secretary was directed to proceed with the completion of the details of the plan to place the proposition in operation. The next meeting was set for September 4, at London, Ohio, at which time the organic law was adopted.

In 1937, Bryan Barnes of Williamstown, Kentucky was elected to serve as president. A committeeman and three directors representing the states of Washington, Ohio and Minnesota were also elected. Until this time there had been a total of seventy-five certificates issued and the first claim was paid in that year.

Meetings were held twice a year until World War II. In 1948 the National Rural Letter Carriers' Association adopted The Guild as the official Death Benefit Department. In 1950 The Guild began to meet just prior to the National Convention and has continued to do so.\*

The Provident Guild is NOT AN INSURANCE. It is a Death Benefit Fund that guarantees you at least 30 times your annual dues and , depending on the number of claims in any given year, can pay up to 90 times your annual dues, as long you are a current dues paying member.

Every POOM in the district will be given the opportunity to decide how the rural carriers in their area would be appreciated and to spend time in some offices. The next district publication will be showing pictures indicating the appreciation of one of the unapprenticed sectors of the Postal Service.

#### Thank You!

I want to say thank you to each and every rural carrier in the state of OHIO for coming to work, doing the best job that you can do each and every day and going home safely to your families at the end of the day. We do not need to hear it every day but hearing a thank you once in a while makes our day. Every regular, PTF or RCA..... Thank you for a job well done!!!!

#### Sunday Work List:

Although Sunday work has always been in the National Agreement, the parameters changed on May 24, 2016 when a Memorandum Of Understanding (MOU) was signed for Sunday/Holiday Delivery Work Lists. The impact was immediately felt in the Ohio Valley District while Northern Ohio, depending on how you look at it, was spared for having to work Sundays and Holidays. That has now changed and most offices have been assigned to a hub office. Leave replacements (PTFs, and all classifications of RCAs) will have the opportunity to either sign the volunteer or non-volunteer section of the work lists. Each list will be established during the same time periods as the relief day work list and each new list shall supersede the previous list. Newly hired RCAs will

have the opportunity to sign the list within the first thirty days of employment.

The hub office (where you report to pick up packages) may or may not have a spoke office or offices. A spoke office is an office that amazon drops packages off at the hub that are delivered to a different office. Amazon determines the hub and spoke offices. In addition, neighboring post offices may be assigned to the hub office to create a larger pool of leave replacements to work.

#### **ARC Hiring:**

Management is allowed to hire ARC (Assistant Rural Carriers) for the sole purpose of working Sundays and Holidays to deliver parcels. The ARCs are the first ones to be scheduled for work every time. The second group of RCAs to be scheduled are the volunteers in alphabetical order rotation regardless of the office. If more leave replacements are still needed then the non-volunteers will be scheduled in an alphabetical rotation. With the addition of the neighboring offices, the theory is that a leave replacement may only have to work once or twice a month.

#### PTFs and Hold Down Carriers:

Despite what everyone thinks, PTFs, auxiliary carriers and "hold down" carriers are not exempt from working Sundays and Holidays. In addition, there are no religious exempts either. According to the analysis of change PTFs may be used to work on Sundays before selecting other leave replacement employees on the Sunday work list.

#### **Auxiliary Carriers:**

Auxiliary carriers are required to take their turn in the rotation as well. "Hold down" carriers are to be the last ones scheduled which means all ARCs, PTFs volunteer and non-volunteers; RCAs including auxiliary carriers volunteer and non-volunteers must be scheduled first. Article 10.5.B allows for any leave replacement to be bypassed if they have approved annual leave for the day.

#### **Contractual Language:**

Unfortunately, there is no contractual language that only allows a leave replacement to work a certain number of days in a row. The job of a union is to find work for the membership and the NRLCA is no different and that is why there is no limit on the number of days that a leave replacement may work. Each district tries to limit the number of days for quality of life (Hint maybe a resolution needs to be submitted)

#### RRECS:

As I am sure that all have heard that RRECS is in the process of being implemented. The effective date of the new evaluations will be March 25, 2023 with another one in about six months. It is imperative that each day every carrier completes the basic scans on their routes.

#### **Sensitive Scanners:**

Yes, I know you can be walking and wondering what scan was just hit on the very sensitive scanners. The NRLCA is working in conjunction with the Postal Service to either grey out for instance the clock in scans or at least add the question do you want to complete this scan. It will help immensely if we have one of those options.

#### **Pre-Disciplinary Interview:**

If by some chance you are called in for a Pre-Disciplinary Interview over this issue of missing scans, please contact a steward. Do not get upset as management has the right to do an investigation. If they issue any discipline for those missed scans or for any other reason – always grieve discipline.

#### **National Mail Count:**

The last time we had a national mail count was in 2018. Think about it that 2019, 2020, 2021, 2022 and 2023... that's five years. In those five years, unfortunately, letter and flat volumes have gone. In addition, most of us were counted with amazon parcels and unfortunately those amazon parcels have gone away.

#### **RRECS Standards:**

The RRECS standards are there but what is missing is the mail volumes. Through no fault of our own, by not having mail counts in the last five years and not having that gradual decline in evaluations, then a drop in our route evaluations may hit us hard. I don't like it but it's the reality of the situation.

#### The Employee Assistance Program:

The Employee Assistance Program, commonly referred to as EAP, is available and the number is 1-800-327-4968. This program does not report back to the Postal Service, and you may discuss anything with them.
